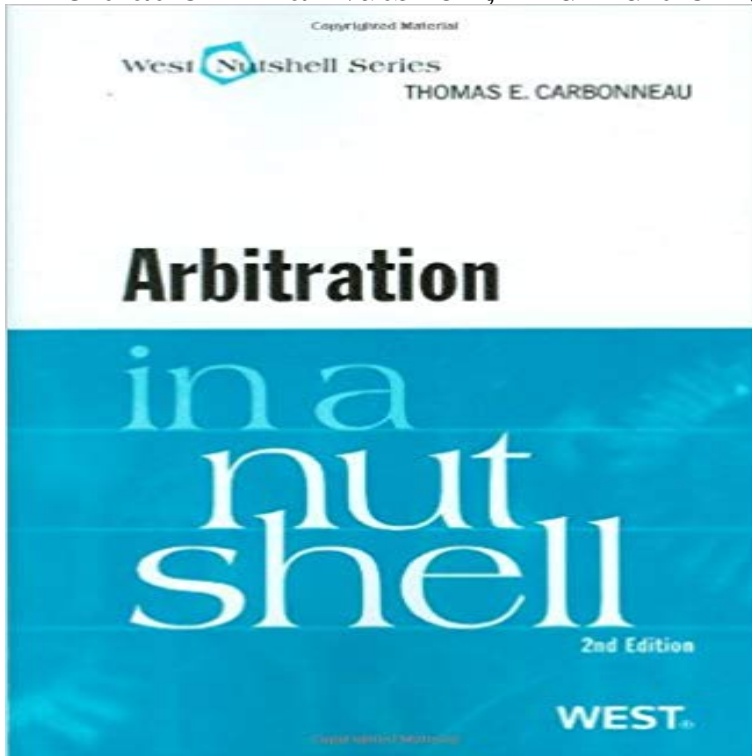


## Arbitration in a Nutshell, 2nd Edition (In a Nutshell (West Publishing))
