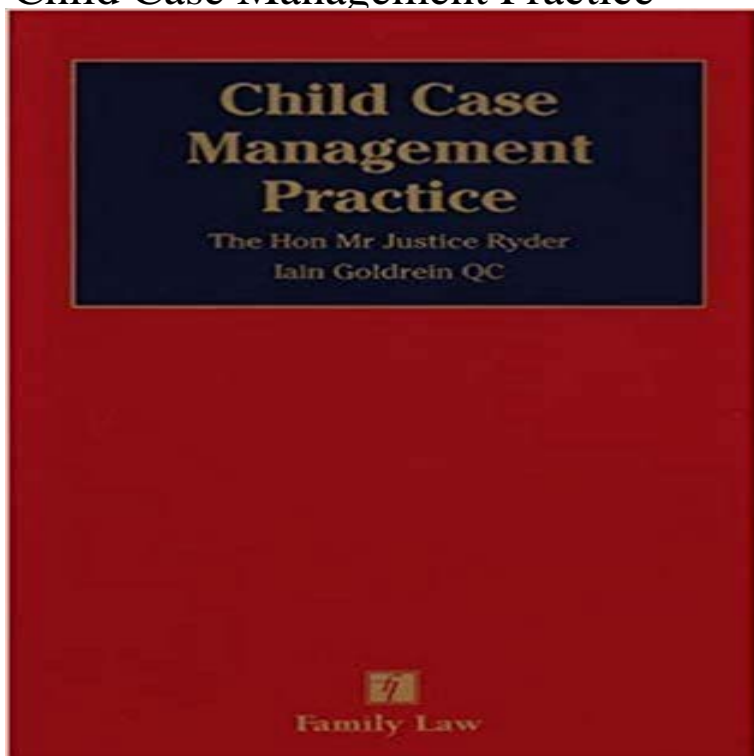


## Child Case Management Practice
