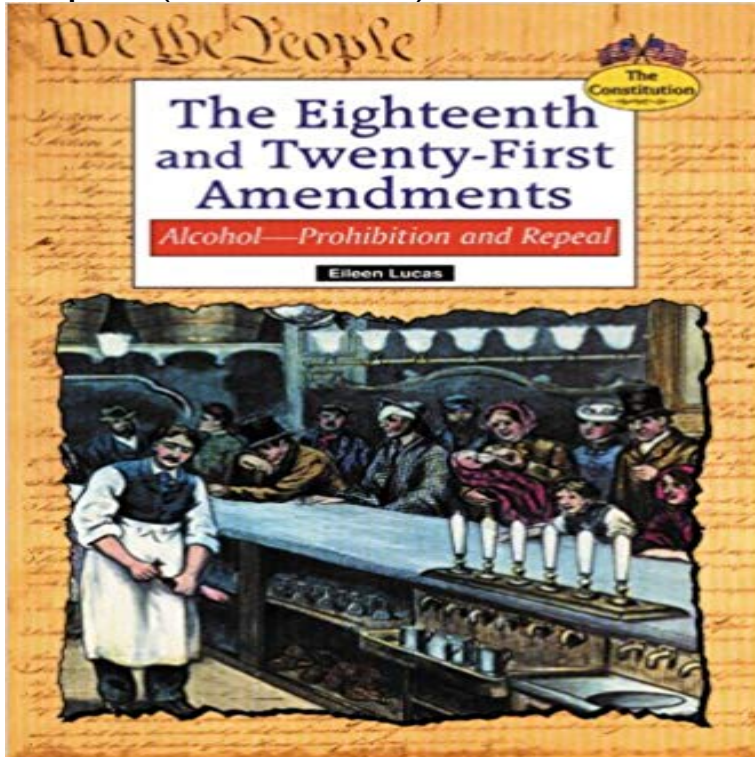


The Eighteenth and Twenty-First Amendments: Alcohol-Prohibition and Repeal (Constitution)
