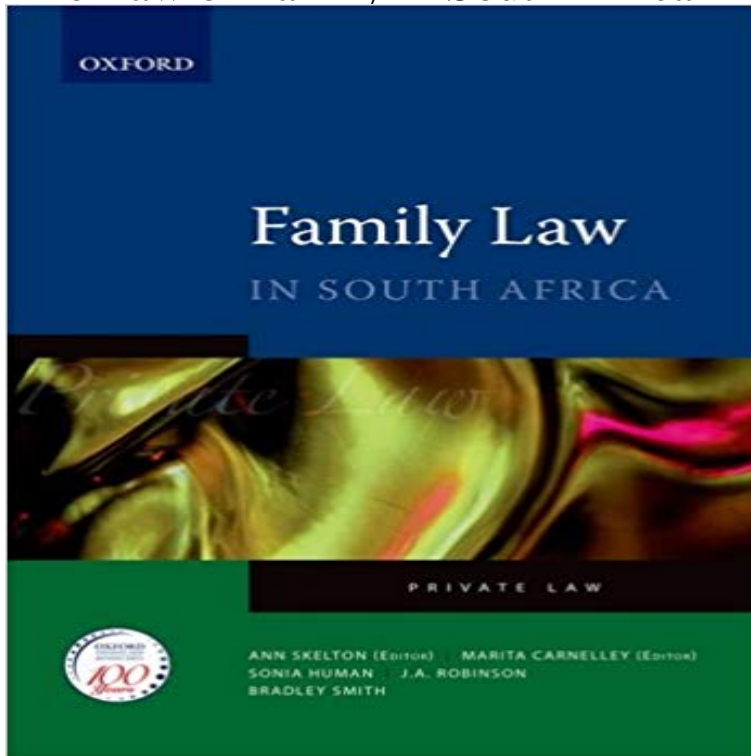


# The Law of Family in South Africa
