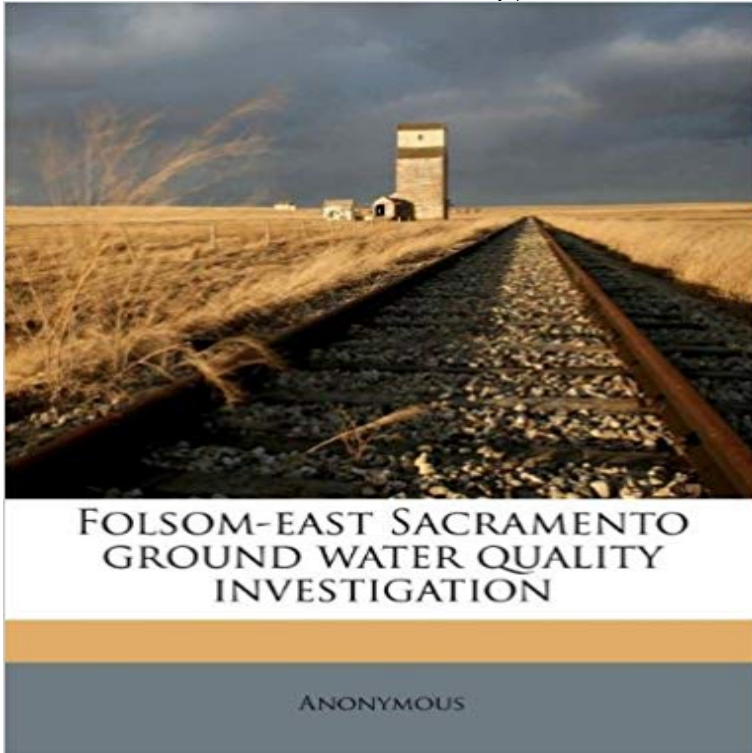


# Folsom-east Sacramento ground water quality investigation
