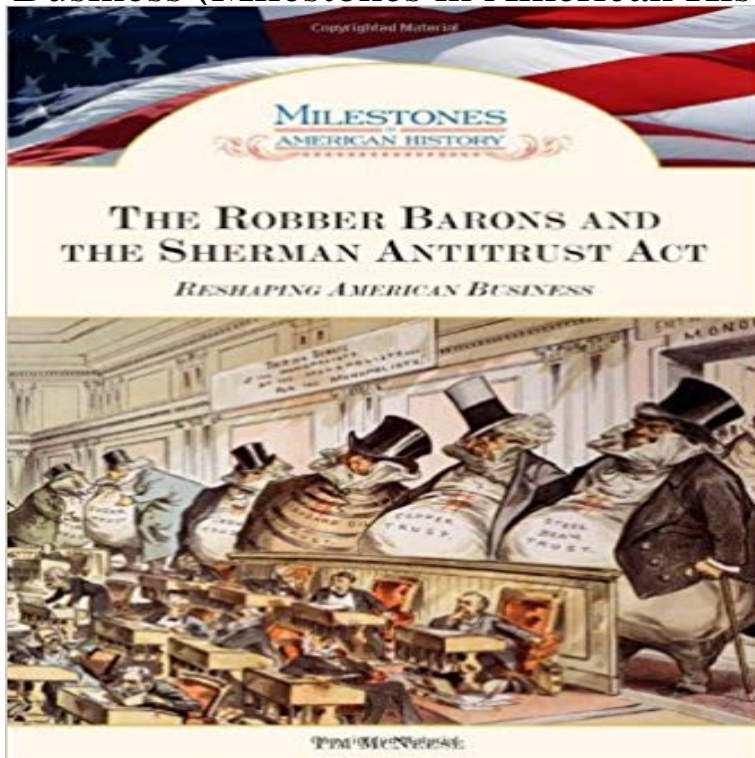


## The Robber Barons and the Sherman Antitrust Act: Reshaping American Business (Milestones in American History)
