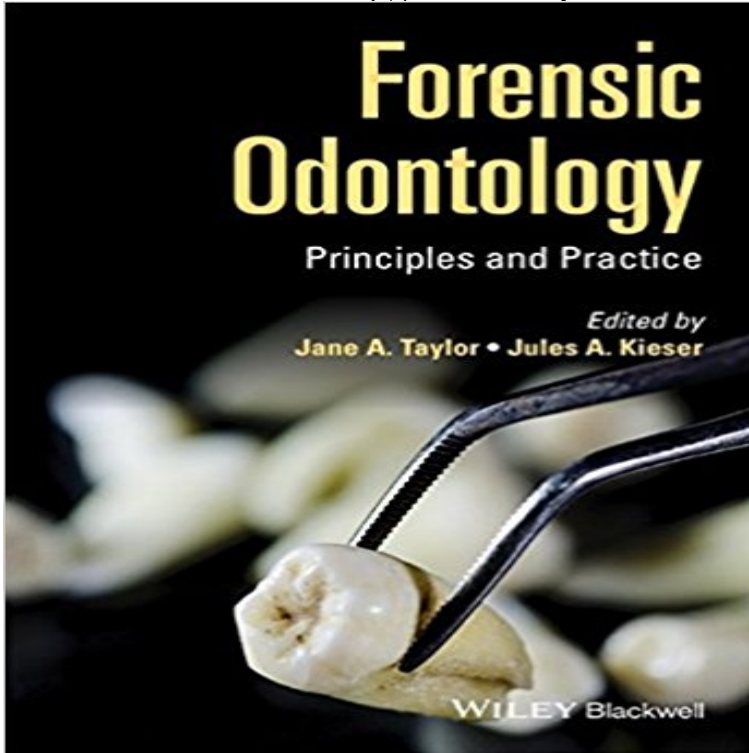


## Forensic Odontology: Principles and Practice
