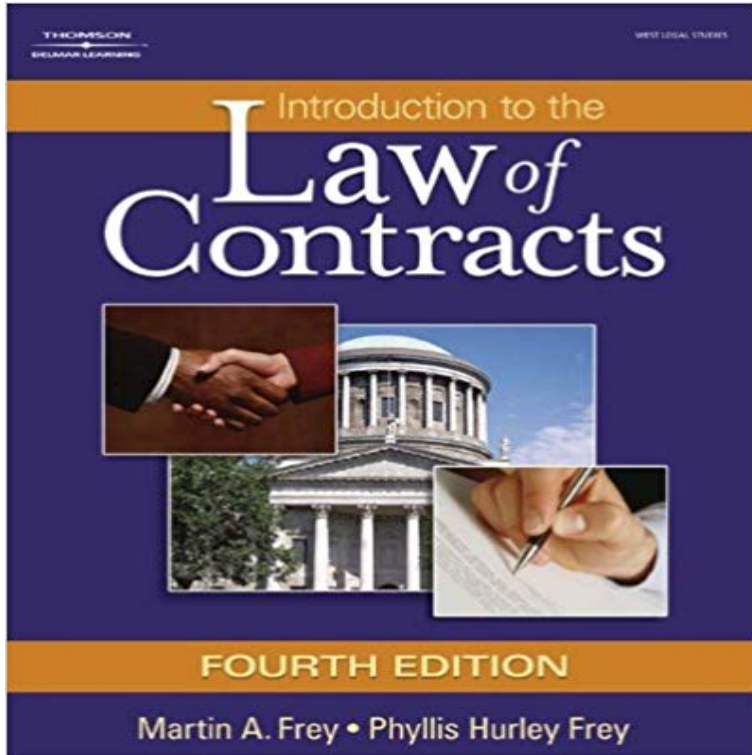


Bundle: Introduction to the Law of Contracts, 4th + Paralegal Online Courses - Contracts on WebCT



An Introduction to the Law of Contracts is now out in the 4th edition. It is still carefully organized around a comprehensive road map that takes the reader through the 6 steps of contract law, but the new edition includes added benefits. There are updated cases and examples, and each chapter ends with review questions to help reinforce the theories addressed in each chapter. The chapters also end with a checklist that helps to highlight the key concepts for the reader. The first of 6 steps investigates what body of law applies to the transaction. The next step addresses the formation of a contract, offer and acceptance. Step 3 develops limitations on the parties freedom to contract, and concepts such as infancy, illegality, duress, and unconscionability are explored. The next step looks at the plaintiffs allegation of the defendants breach. Step 5 organizes the defendants responses to the plaintiffs allegation of breach, categorizing it into one of two basic types that is then further explored. The final step develops the plaintiffs remedies for the defendants breach of contract. Paralegal students and professionals alike will benefit from this thorough and highly readable book that is completely current and has a focus on retention.
