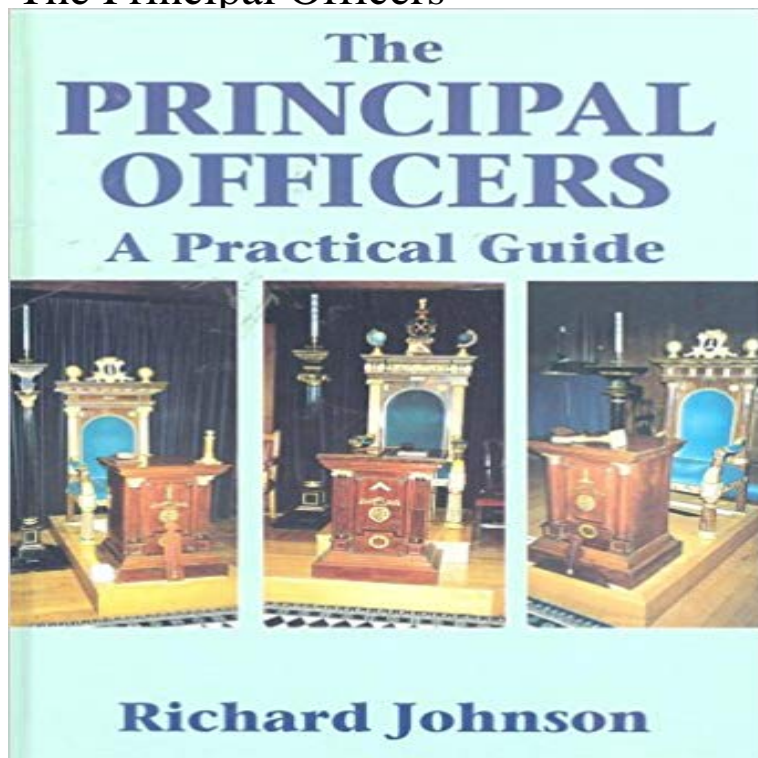


The Principal Officers
