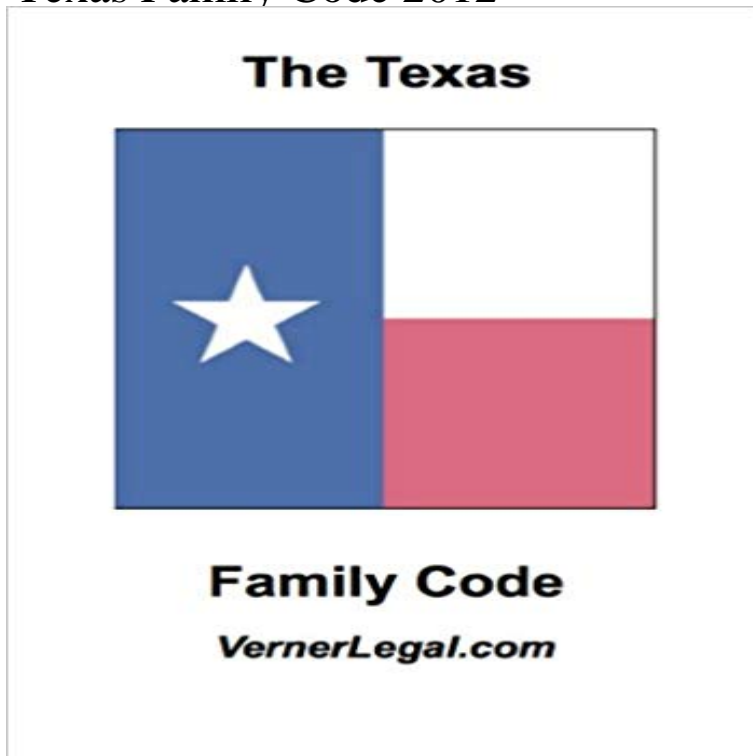


# Texas Family Code 2012
