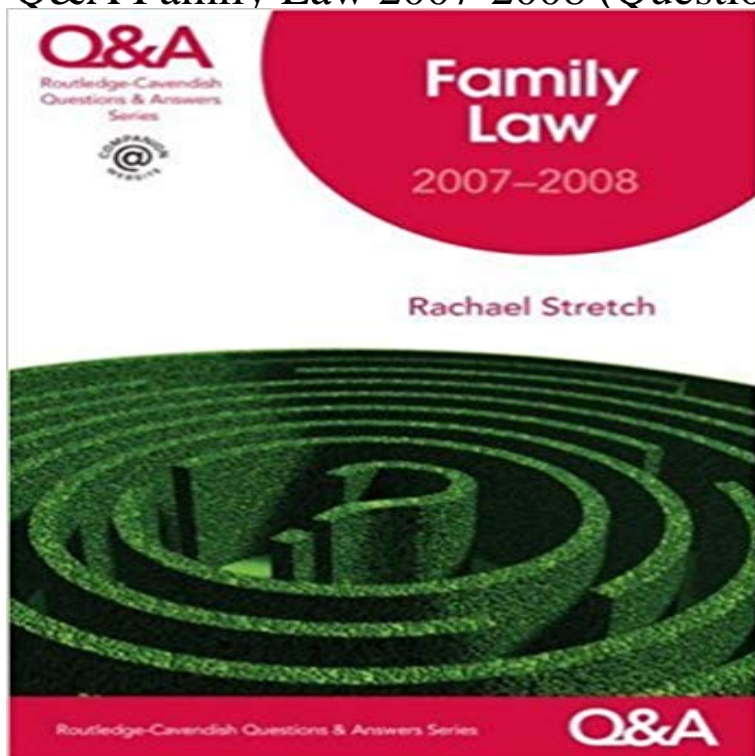


Q&A Family Law 2007-2008 (Questions and Answers)
