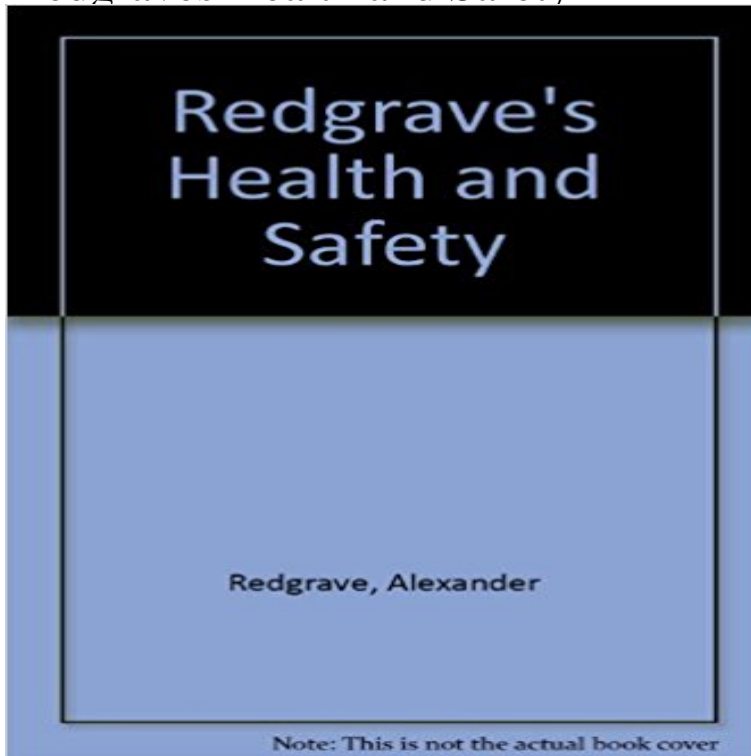


Redgraves Health and Safety

This edition of Redgrave brings you: coverage of important legislation, such as the Six Pack of regulations which govern all working establishments in the country; commentary on significant Acts and regulations, for example the Management of Health and Safety at Work Regulations 1999, the Workplace (Health, Safety and Welfare Regulations 1992 and the Health and Safety Act 1974); and reference to both English and Scottish cases. Key cases covered include: Beck v United Closures and Plastics Ltd (2001 - workplace); Cross v Highlands and Islands Enterprises (2001 - risk assessments); R v Nelson Group (Maintenance) Ltd (1998 - reasonably practicable); and, R v F Howe & Sons (1999 - guidance on fines). The book offers regular updates by way of annual supplements, and a thorough source of fully annotated materials with additional commentary from the general editor. It is up-to-date with legislative and case law developments. Since its first edition in 1878, Redgraves Health & Safety has been considered a practical research tool, unrivalled in providing complete up-to-date coverage of health and safety legislation and case law developments.
