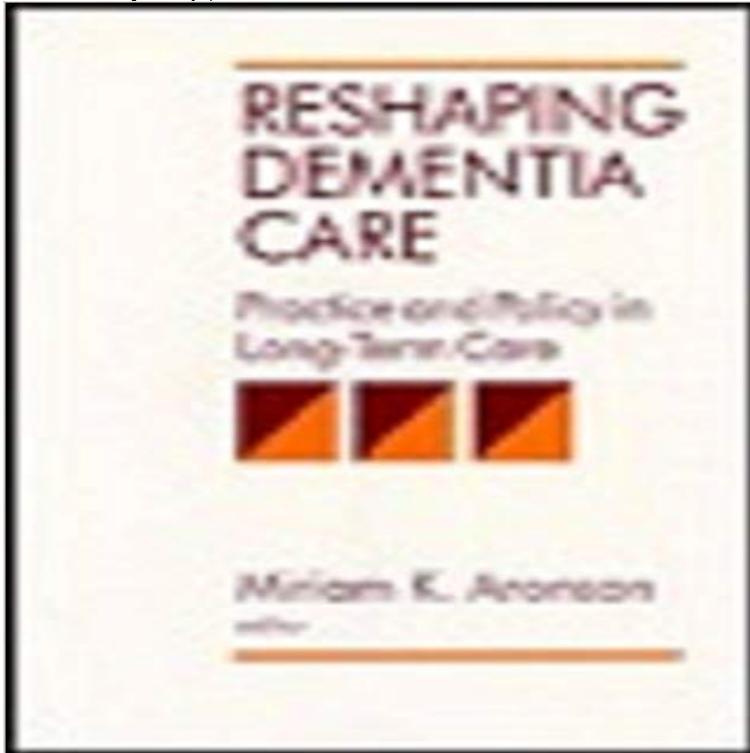


Reshaping Dementia Care: Practice and Policy in Long-Term Care



Innovative approaches to dementia care in the nursing home are the subject of this volume. Special programmes designed to accommodate patients, including special care units, in-house day care, nursing unit-based services and social day care, are described. Also explored are: legal and ethical issues related to dementia; reimbursement; staff training; and increasing costs.
