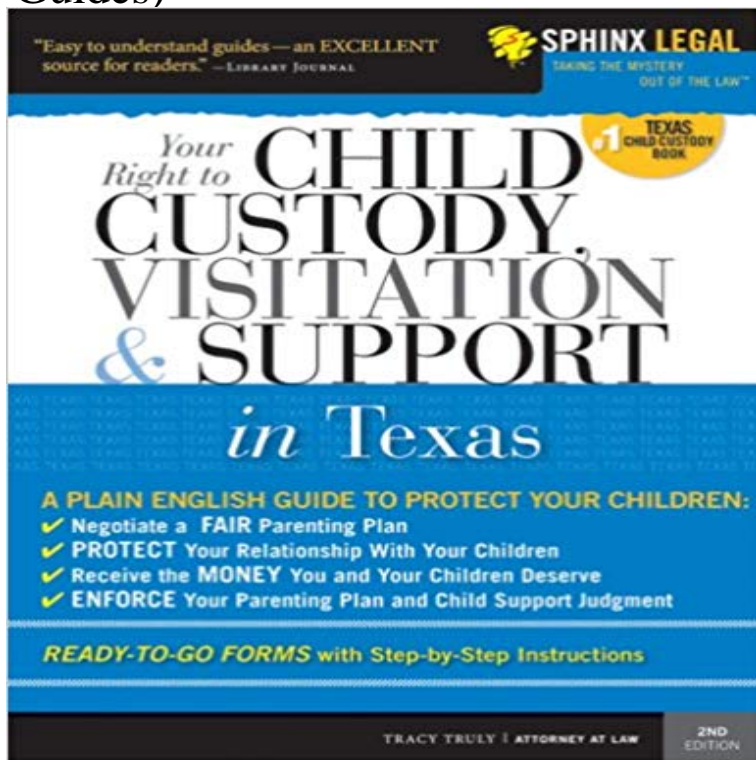


Child Custody, Visitation and Support in Texas, 2E (Legal Survival Guides)
