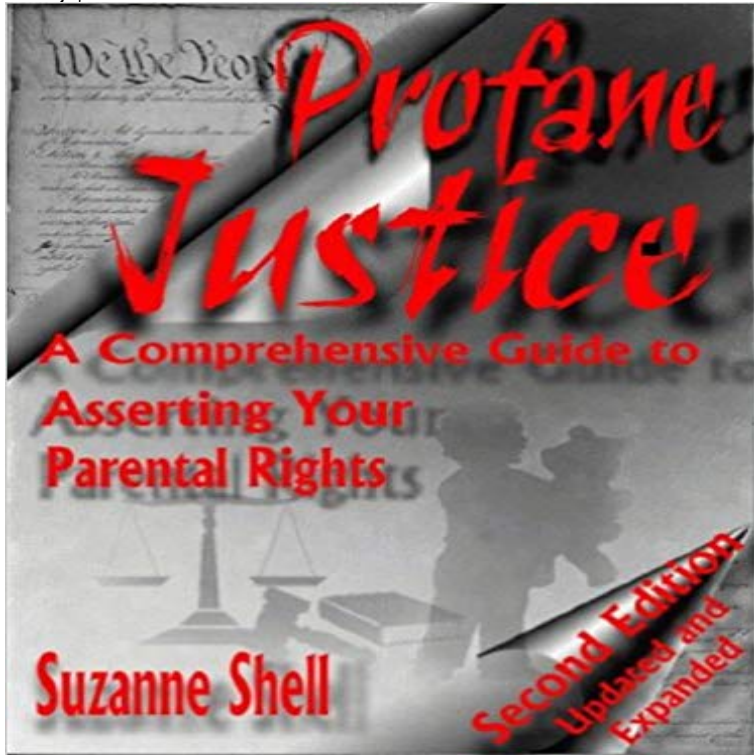


Profane Justice: A Comprehensive Guide to Asserting Your Parental Rights

It examines other discipline techniques in light of their effectiveness and their potential risks for being charged with child abuse when parents employ them. The book provides in-depth coverage of what activities put parents at risk of child abuse charges, including a discussion of warning signs that indicate a child could be considering turning them in for abuse.
