Entertainment Merchants Association, which concerns the constitutionality of a California law banning the sale of violent video games to minors. This case takes up where Ginsberg v. New York (1968) left off. J.D.B. v. North Carolina, concerning how to apply Miranda when police interrogated a 13-year-old special ed student at school. Camreta v. Greene, which will decide whether the usual Fourth Amendment requirements, including the warrant requirement, apply when police want to interview a child about child abuse or neglect allegations Graham v. Florida, in which the Court held that the Eighth Amendments Cruel and Unusual Punishments clause does not permit a juvenile offender to be sentenced to life in prison without parole for a non-homicide crime. The decision, which relies heavily on Roper v. Simmons, was a striking departure from the Courts long-standing death is different jurisprudence as well as a signal of Justice Kennedys enduring belief
