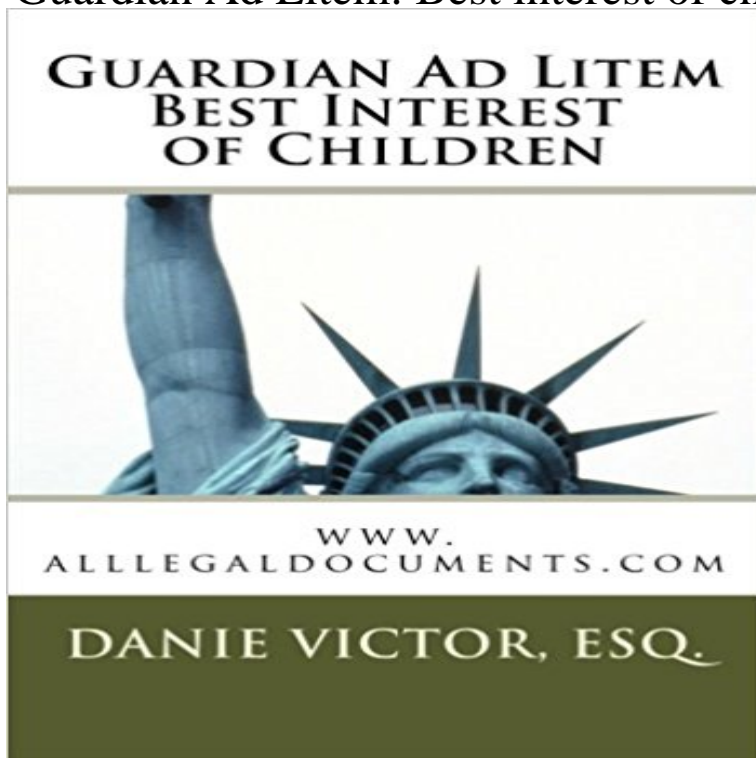


Guardian Ad Litem: Best interest of children, Forms & Guides
