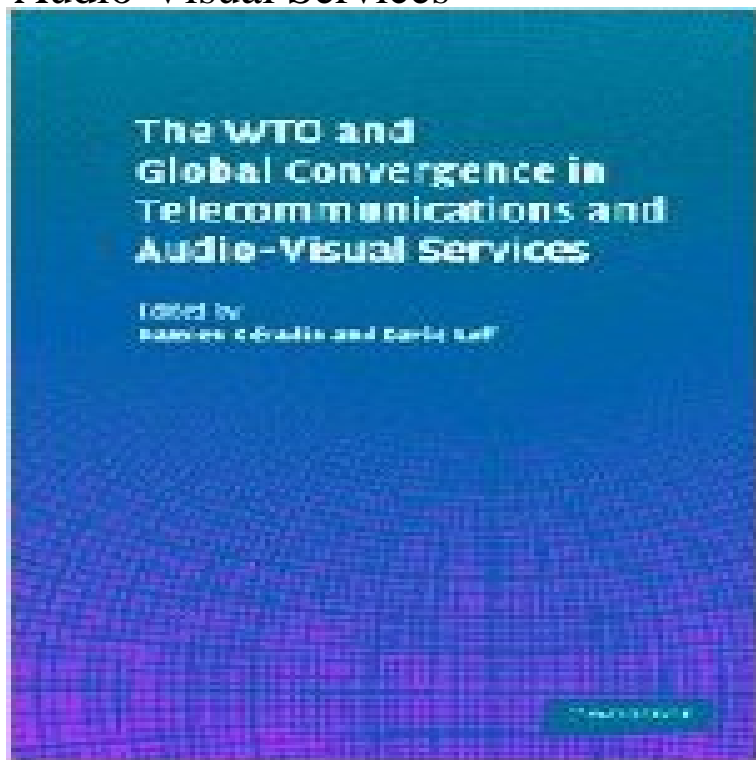


# The WTO and Global Convergence in Telecommunications and Audio-Visual Services
